No. GH/SH/08/2023/PVS/102013/631(PF2)/S:- WHEREAS the Government of Gujarat has, vide Government Notification, Education Department No. GH/SH/14/2020/PVS/102013/631/S, dated the 13th March, 2020, framed the Gujarat Professional Technical Educational Colleges or Institutions (Procedure for Declaration of Centre of Excellence) Rules, 2020 (hereinafter referred to as "the said rules") for regulating the procedure for declaration of "Centre of Excellence" in the Colleges, Institutions or Private Universities;

AND WHEREAS the Government of Gujarat has, vide Government Notification, Education Department No. GH/SH/48/COE/102020/459/S, dated the 4th January, 2022 (hereinafter referred to as "the said notification"), notified certain Universities as the "Centre of Excellence" under the powers conferred by clause (b) of sub-rule (1) of rule 4 read along with clause (d) of sub-rule (1) of the rule 2 of the said rules;

AND WHEREAS the Government of Gujarat considers it necessary to exempt the said notified Universities from certain provisions of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (hereinafter referred to as "the said Act");

NOW, THEREFORE, in exercise of the powers conferred by Section 13A of the said Act, the Government of Gujarat, hereby, exempts, from the provisions of the said Act, the Universities as specified in the said notification, subject to the following terms and conditions, namely:

(1) The exemption shall be applicable to the College, Institution or Private University declared under the said notification, as the 'Centre of Excellence', for the academic years 2023-24 and 2024-25, only for the courses, as notified under clause (k) of

- Section 2 of the Act, run by such Colleges, Institutions or Private Universities.
- (2) All admissions to the professional courses, as notified under clause (k) of Section 2 of the Act, for the College, Institution or Private University declared as the 'Centre of Excellence', shall be in accordance with the guidelines, norms and standards as specified by the respective statutory bodies i.e., All India Council for Technical Education (AICTE) / Pharmacy Council of India (PCI) / Council of Architecture (CoA).
- (3) The Colleges, Institutions or Private Universities shall strictly follow the academic calendar as notified by respective competent authorities.
- (4)Minimum 33% of the sanctioned intake shall be offered as "Government Seats". The admissions on the Government Seats shall be conducted by the respective Admission Committee constituted in accordance with the provisions of the said Act. These seats shall be offered to the students who have passed the qualifying examination from eligible Board or University located in the State of Gujarat. The students who qualify as per the eligibility criteria and possess domicile of the State of Gujarat shall also be eligible for the admission. The College, Institution or Private University declared as a 'Centre of Excellence' shall provide information in advance to the respective Admission Committee along with due undertaking for preparation of merit list purely based on the Common Entrance Test of relevant credibility at national or state level i.e., Gujarat Common Entrance Test (GUJCET)/ Common Admission Test (CAT) / Joint Entrance Examination (JEE)/ National Eligibility-cum-Entrance Test (NEET)/ Common Management Admission Test (CMAT) / National Aptitude Test in Architecture (NATA) or others as applicable, for admitting the students into respective professional courses. The admission on the 33% Government seats shall be made in accordance with the provisions of the said Act.

- (5) Maximum 15% of sanctioned intake may be filled with Non Resident Indian (NRI) students as defined by the competent authority; and as per the guidelines published by the respective Admission Committee of the State Government.
- (6) All the provisions of the said rules and the relevant amendments from time to time shall be applicable to the Colleges, Institutions or Private Universities declared as the 'Center of Excellence'. The fee structure informed by way of a declaration to the Appellate Committee in accordance with the provisions of sub-rule (1) of rule 8 of the said rules or, as the case may be, the fee structure as modified under sub-rule (3) of said rule 8, shall be intimated to the students prior to the commencement of admission.
- (7) The Colleges, Institutions or Private Universities declared as 'Centre of Excellence' shall submit an undertaking to the effect that it shall not do profiteering and/or charge capitation or donation fees.
- (8) The University Grant Commission (UGC) / All India Council for Technical Education (AICTE) norms/guidelines shall be followed for the refund of the fees in case of cancellation or withdrawal of the admission by the students.
- (9) The total scholarship amount per year shall be between 3% to 5% of the fees collected per year by the Colleges, Institutions or Private Universities out of which 20% scholarship shall be awarded to the students of Gujarat Domicile.
- (10) The Colleges, Institutions or Private Universities may adopt, at least, three institutions for mentoring and extend their full facilities and support for the betterment and development of the mentee institutions as well as the students.
