Gujarat No. GH/SH/48/COE/102020/459/S:- In pursuance of the provisions of clause (d) of sub-rule (1) of rule 2 read with clause (b) of sub-rule (1) of rule 4 of the Gujarat Professional Technical Education Colleges or Institutions (Procedure for Declaration of Centre of Excellence) Rules, 2020, the Government of Gujarat hereby, on the recommendation of the High Level Committee, notifies the following Universities, as "Centre of Excellence" for the period of three years from the date of publication of this notification in the Official Gazette.

> The status of the Center of Excellence shall be applicable only for the courses as specified in clause (k) of section 2 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (hereinafter referred to as "the said Act") and run by the constituent Institutions of the Universities within the State of Gujarat.
